

Quarterly Performance







Deal flow has rebounded in the first half of 2021 as the world "re-opened", with confidence in the market and record low interest rates fueling M&A activity.

During the first half of 2021, there were 113 M&A transactions that closed within the chemicals industry. As a result, the total transaction value in the first half of 2021 increased by 66.4% compared to the second half of 2020 (\$23.5 billion). Commodity chemicals led the industry in terms of transaction volume (58), trading at an average EV/EBITDA multiple of 9.8x. Looking at the LTM performance of the chemicals industry relative to the S&P 500, only specialty chemicals underperformed the S&P 500, returning 34.5% vs. 37.9%.

The market witnessed ten billion-dollar transactions in the first half of 2021 including: the acquisition of Ritter GmbH by Avantor Performance Materials, LLC for \$1.4 billion; the acquisition of the PMMA and Activated MMA Business of Arkema S.A. by Trinseo S.A. (NYSE:TSE) for \$1.4 billion; the acquisition of the Resins & Functional Materials Businesses of N.V. Koninklijke DSM by Covestro (EXTRA:1COV) for 1.9 billion; and the acquisition of Tikkurila Oyj (HLSE:TIK1V) by PPG Industries, Inc. (NYSE:PPG) for 1.9 billion. Additionally, a few notable transactions were announced: the acquisition of Ferro Corporation (NYSE:FOE) by Prince International Corporation for \$2.3 billion; the acquisition of W.R. Grace & Co. (NYSE:GRA) by Standard Industries Inc. for \$6.7 billion; and the acquisition of Lonza Specialty Ingredients by Cinven Limited and Bain Capital Private Equity, LP for \$4.7 billion.

Senior executive confidence in the economic market as well as high deal valuations are driving strategics desire to sell. Large corporates, after little activity in 2020, have refocused their attention on non-core divestitures while taking advantage of the ample financing availability.

There has also been an increase in cross-border transactions in order to mitigate supply chain disruptions. The commodity chemicals market has, due to supply chain risk, continued to divest non-core assets in order to center their attention on core businesses. On the other hand, specialty chemical companies are pursuing growth opportunities as a result of demand changes within the hygiene and pharmaceutical sub-sectors

Strategic buyers including public and private corporations have led deal activity as owners are attempting to beat the potential capital gains tax increase introduced by the Biden administration. However, financial buyers expect to become more active as they attempt to make up for the lack of activity in 2020. After putting sales on hold, owners are keen to discuss M&A opportunities with financial buyers. Since economics have improved and the market is ripe for M&A activity, financial buyers are well-positioned to capitalize on the opportunities with abundant deployable capital.

Asia-based companies are becoming increasingly pertinent in the chemicals M&A market. Potential buyers based in Malaysia, Thailand, India and China have been exploring more deals in the market than ever before. These companies are using M&A as an opportunity to expand plant operations rather than building additional plants themselves. The Asia / Pacific region accounted for 51.7% and 45.6% of closed transactions in the first and second quarter of 2021, respectively.














Transaction Activity by Geographic Region






Transaction EV/EBITDA Multiples




