Quarterly Performance



Deal flow continues to fuel economic growth as potential tax law changes and low interest rates spark *M&A* activity.

The M&A market has seen a rise in accelerated processes throughout the third quarter as dealmakers aim to close deals by year-end. Several companies are working on integration strategy and due diligence in parallel, enabling strategic buyers to realize synergies and gain value at a faster rate than seen in previous years.

During the third quarter of 2021, there were 61 M&A transactions within the chemicals industry that closed, up 7.0% compared to the second quarter of 2021 (57). Commodity chemicals led the industry in terms of transaction volume (30), transacting at an average EV/EBITDA multiple of 11.3x. The chemical industry has experienced an increase in EV/EBITDA multiples as investors react to post-COVID projections. The specialty chemicals subsector is a driving factor in higher deal multiples with an average EV/EBITDA of 13.9x in the third quarter of 2021, up 18.8% from the second quarter of 2021 (11.7x). The flavors and fragrances sector within the specialty chemicals industry has provided an attractive investment opportunity to companies in the new ESG-conscious environment. Other chemical subsectors have also witnessed an increase in transaction multiples as demand within the chemical industry as a whole is on the rise.

The supply chain disruptions caused by the pandemic persist within the chemicals industry, with many pushing through price increases to customers. Customers have accepted these price increases as raw material shortages have trickled through the supply chain resulting in an inability to successfully fulfill orders.

The market witnessed six billion-dollar transactions in the third quarter of 2021 including: the acquisition of Lonza Specialty Ingredients by Cinven Limited and Bain Capital Private Equity, LP for \$4.7 billion; the acquisition of W.R. Grace & Co. by Standard Industries Holdings Inc. for \$6.7 billion; the acquisition of Niacet Corporation by Kerry Group plc (ISE:KRZ) for \$1.0 billion; and the acquisition of the Performance Chemicals Business of PQ Group Holdings Inc. by Cerberus Capital Management, L.P. and Koch Minerals & Trading, LLC for \$1.1 billion. Additionally, a few notable transactions were announced: the acquisition of Solenis International LLC by Sigura Water for \$5.3 billion; the acquisition of Kraton Corporation (NYSE:KRA) by DL Chemical Co., Ltd. for \$2.5 billion; and the acquisition of Microbial Control Business Unit of International Flavors & Fragrances Inc. by LANXESS Aktiengesellschaft (XTRA:LXS) for \$1.3 billion.

Asia-Pacific led in terms of M&A activity throughout the first half of 2021, but recent deal announcements indicate that the North American and European markets will soon experience heightened deal flow. North America and Europe have both seen large deal announcements in the third quarter as excess dry powder, new PE buyers and low interest rates bolster activity.

Corporate chemical companies are still the prominent buyer group within the industry as strategic buyers accounted for an overwhelming majority of the 61 closed M&A transactions (57). Strategic buyers are continuing to use acquisitions as a key strategy in product expansion while sellers attempt to close deals before the year-end tax change. However, financial buyers should not be dismissed as recent M&A transaction success within the chemical industry has interested new private equity players. Additionally, low interest rates and excess dry powder have provided financial buyers with the ability to outbid strategic buyers in auction processes.





EV/Revenue


LTM EV/Revenue Multiples¹




Transaction Multiples
